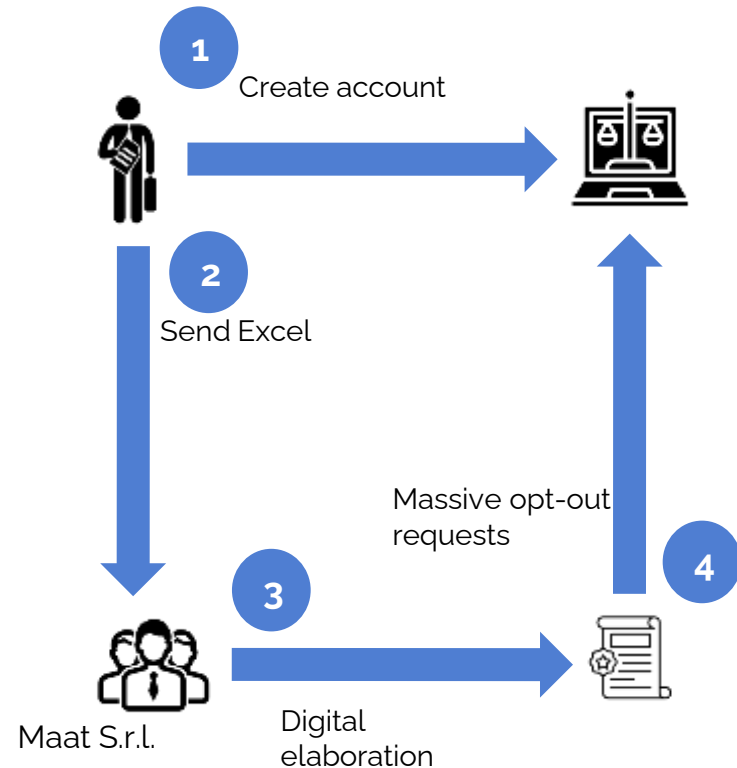
Let us handle your opt-out requests
